

Families qualify for McKinney-Vento if:

- Sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason.
- Living in motels, hotels, trailer parks, or camping grounds due to lack of alternative housing.
- Living in emergency, transitional, or domestic violence shelters.
- Living in cars, parks, public spaces, or similar spaces.
- Unaccompanied Youth



KNOW YOUR RIGHTS

- Staying in the same school even if you move, and receiving transportation to that school, as long as it is in the student's best interest
- Enrolling in school immediately without the documents schools usually require
- Receiving free school meals
- Receiving help with getting school supplies and other needs
- Extra support for youth who are on their own
- Help connecting young children with early childhood services

Bristol Township School District prides itself in making sure all families and students are provided with the support they need. These supports include:

- Immediate enrollment in school
- Free School Lunch
- Transportation
- After school support
- School supplies

Bristol Township School District will also provide financial assistance to families such as:

- Fuel Cards
- Gift Cards to purchase food or clothing
- Waiver of fees for such things as prom tickets or any other school events

Dispute Resolution Process

If a dispute arises over school selection or enrollment, the child / youth involved must immediately be admitted to the school in which they are seeking enrollment, pending resolution of the dispute.

If the parent, guardian, or unaccompanied youth is dissatisfied with the LEA's disposition of a dispute or would like to raise any issue of the McKinney-Vento Act noncompliance, they may file a complaint or appeal with a McKinney-Vento site or regional coordinator or with the state coordinator.

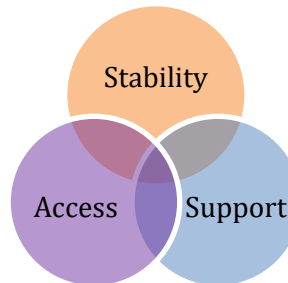
